Western Australian Police currently does not recognise firearms licences issued in other Australian States or Territories.

For those competitors who **register prior to 31<sup>st</sup> July 2010** and **supply details of their firearm(s)** they bring into Western Australia, a Group Temporary Permit will be obtained free of charge.
